We hope you are keeping well and safe.

During the first quarter of 2023, we set the pace to strengthen the program and its reach. Globally, we completed over 600 safety trainings and 400 assessments. As an important milestone, LABS will expand into Indonesia this year and the groundwork for the launch is progressing steadily.

The LABS Standards & Methodology was revised in India to include the home textiles industry, thus providing access to additional factories. In March 2023, Good Practice sessions were conducted in India, Vietnam, and Cambodia for factories and other stakeholders. There were over 400 participants in these sessions with representatives from factories, brands, textile associations, and the respective government representatives.

LABS is also launching a chat platform to strengthen outreach to workers and provide an agency to report incidents.

We hope you enjoy these updates and look forward to any inputs you may have.


Common assessment findings



Structural Safety

- Uneven floor-load distribution on suspended floors
- Exposed reinforcements on roof slab
- Severe corrosion on steel frames
- Cracks on structural members (e.g., concrete beams and columns)
- Absence of documentation (e.g., structural diagrams, geo-technical reports, floor-load plans, and soil reports)






Fire Safety

- Rolling shutters on exit doors
- Fire-rated doors and fire-rated enclosures lacking
- Centralized fire-alarm system unavailable
- Lockable devices/mechanisms found on exit doors
- Overhead signages not existing on escape paths
- Handrails not provided on both sides of the staircase






Electrical Safety

- Heavy lint and dust inside switchboards/distribution boards (DBs)
- Protective earthing (PE) to DBs, MS roof truss, transformer fencing, and battery bank racks not provided
- Lightning protection system not supplied
- Flammable coating inside distribution panels
- Numerous hotspots with temperatures between 70.2*C and 104.7*C

Remediations

Fire

India

Data below represents 85 factories where 227 follow-up visits were conducted

- 99% of the factories installed emergency lights
- 96% of the factories removed temporary obstacles on the evacuation pathways
- 97% of the factories installed illuminated exit signages
- 89% of the factories removed the locking mechanisms from exit doors

Vietnam

Data below represents 185 factories where 437 follow-up visits were conducted

- 100% of the factories removed the temporary obstacles on the evacuation pathways
- 85% of the factories provided additional emergency lighting
- **91%** of the factories added fire alarms
- 76% of the factories installed extra fire detectors
- 89% of the factories remediated issues related to exit doors

Cambodia

Data below represents 25 factories where 25 follow-up visits were conducted

- 100% of the factories installed emergency lights
- 100% of the factories removed the temporary obstacles on the evacuation pathways
- 93% of the factories installed illuminated exit signages
- 59% of the factories removed the locking mechanisms from exit doors

Electrical

India

- 90% of the factories removed lint and dust from electrical panels and DBs
- 98% of the factories reduced the high temperatures in electrical panels and DBs
- 96% of the factories provided PE connections for electrical components

Vietnam

- 92% of the factories removed lint and dust from electrical panels and DBs
- 98% of the factories reduced the high temperatures in electrical panels and DBs
- 100% of the factories remediated issues regarding the Supplies to Life Safety Systems
- 86% of the factories provided PE connections

Cambodia

- 86% of the factories removed lint and dust from electrical panels and DBs
- 83% of the factories reduced the high temperatures in electrical panels and DBs
- 82% of the factories provided earthing connections for the electrical components

Structural ----

India

- 78% of the factories mended cracks in beams and columns
- 79% of the factories eliminated the corrosion in nonengineered structures (such as MS Shed)
- 82% of the factories removed the dampness in walls

Vietnam

- **82%** of the factories remediated the missing/incomplete bracing in steel buildings
- 75% of the factories repaired the visible distress in structural members (e.g., cracks on columns, beams, or slabs)
- 75% of the factories provided the Allowable Loading Plans throughout the factory building

Cambodia

- 89% of the factories mended cracks in beams and columns
- 100% of the factories eliminated the corrosion in non-engineered structures
- 86% of the factories removed the dampness in walls

During the process of joining LABS, I was able to assess the current level of safety, identify hazards, ensure safety for workers, and limit risks affecting the development of the factory. In addition, LABS has helped me improve my knowledge of structural safety, electrical safety, fire safety. From there, we can further improve our safety management system, better control hazards and risks, find the root cause to prevent future incidents.

India: Three non-related LABS calls received (mainly HR)

Vietnam: There were 21 non-related LABS calls regarding HR issues and general enquiries

Through the assessment, the LABS safety standards were better understood to further improve the factory and providing training to workers, staff, supervisors, and managers will improve understanding of safety standards. Greatly assisted and provided workers and staff with extensive knowledge about safety and workplace hazards. Key Outreach and Events

Good Practices webinars were conducted for factories in India, Vietnam, and Cambodia to obtain feedback from factories, share success stories and learnings, and discuss the next steps to complete the graduation process. Approximately 400 people participated in these sessions, organized at country levels

India -----

 A session on updating LABS Standards & Methodology to include the home textiles industry was conducted by QIMA and LABS for inspection firms

Vietnam

- **February 6:** LABS conducted a quarterly meeting with the VITAS, Better Work Vietnam, and Ministry of Construction in Vietnam, in February to discuss planned activities for 2023. Overall a positive feedback was received on the LABS Program and the participants committed support to collaborate on upcoming events and field-level activities.
- March 23-24: LABS participated in the Vietnam Textile and Apparel Association (VITAS) sustainable days - Vietnam Texfuture 2023 events. The LABS team presented on "Building Safety within the Apparel and Footwear industries" to establish a channel to share good practices, learning, and technical viewpoints and promote partnerships for the sustainable development of Vietnam's textile and garment industry

Cambodia

- 1. **February 1:** A meeting with H.E. KENG Somarith, Secretary of State of the Ministry of Justice, was conducted to address the non-compliance of factories' safety standards and to ensure gender equality in the hiring/promotion practices within the factories
- 2. **February 6:** A meeting with Rajiv Pradhan, Country Director at Swisscontact (an NGO funded by the Swiss government) was held to discuss potential collaboration/funding of skills' development for factory workers and management teams
- 3. **February 13:** Organized by EuroCham Cambodia's Garment & Manufacturing committee, a meeting with Secretary of State H.E. Dr. TY Norin and Under-Secretary of State H.E. Victor Jona was held on renewable energy and preliminary talks of potentially adopting LABS Standard (electrical code) into policy
- 4. February 20: A joint sharing session with representatives of VF Corp. was conducted at the ILO-BFC office on program updates, challenges, remediation, and P1 issues. The next joint sharing session is tentatively scheduled for the end of April 2023, where BFC would present their findings and challenges. Another joint workshop with ILO-BFC, TAFTAC, and representatives from the Brands, factories, and relevant government ministries was tentatively scheduled for June.

March 24: Noida, India

A short circuit was blamed for a fire at a textile-printing factory in Sector 10. Ten workers narrowly escaped
