Common assessment findings



Structural Safety

- Uneven floor-load distribution at suspended floors
- Exposed reinforcements at roof slab
- Severe corrosion at steel structures
- Cracks at structural and non-structural members (e.g., concrete beams, columns and walls)
- Missing documentation (e.g., structural diagrams, geotechnical and soil reports and floor-load plans)

- Rolling shutters at exit doors
- Fire-rated doors and fire-rated enclosures not provided
- Centralised fire-alarm system unavailable
- Insufficient emergency lights at escape pathways
- Lockable devices/mechanisms at exit doors
- Overhead signages not existing at escape pathways

Electrical Safety

- Heavy lint and dust inside switchboards/distribution boards (DBs)
- Earthing to DBs, MS roof truss, transformer fencing and battery-bank racks not provided
- Lightning-protection system not supplied
- Flammable coating inside distribution panels
- Numerous hotspots with temperatures in electrical panels from 70.2°C to 128°C

Remediations

India

The data below comprises 101 factories where 295 follow-up visits have been conducted.

Fire Safety:

- 99% of the factories have installed emergency lights
- 96% of the factories have removed the temporary obstacles at evacuation pathways
- 97% of the factories have installed illuminated exit signages
- 89% of the factories have removed the locking mechanisms from exit doors

Electrical Safety:

- 90% of the factories have cleared the lint and dust from electrical panels and DBs
- 98% of the factories have reduced the high temperatures in electrical panels and DBs
- 96% of the factories have provided earthing connections for electrical components

Structural Safety:

- 78% of the factories have fixed the cracks at beams and columns
- 79% of the factories have removed corrosion at nonengineered structures (such as MS Shed)
- 82% of the factories have eliminated the wall dampness

Vietnam

The data below comprises 202 factories where 536 follow-up visits have been conducted.

Fire Safety:

- 100% of the factories have removed the temporary obstacles at evacuation pathways
- 91% of the factories have installed additional emergency lighting
- 93% of the factories have added fire alarms
- 78% of the factories have provided more fire detectors
- 93% of the factories have remediated issues at exit doors

Electrical Safety:

- 93% of the factories have removed the lint and dust from electrical panels and DBs
- 98% of the factories have lowered the high temperatures at electrical panels and DBs
- 100% of the factories have remediated issues related to the Supplies to Life Safety Systems
- 88% of the factories have provided protective-earthing connections

Structural Safety:

- 85% of the factories have rectified the issues of missing/ incomplete bracing at steel buildings
- 82% of the factories have repaired the visible distress at structural members (e.g., cracks at columns, beams or slabs)
- 74% of the factories have provided the Allowable Loading Plans throughout the factory building

Cambodia

The data below comprises 53 factories where 104 follow-up visits have been conducted.

Fire Safety:

- 93% of the factories • have mounted emergency lights
- 96% of the factories have cleared the temporary obstacles at evacuation pathways
- 66% of the factories • have installed illuminated exit signages
- 63% of the factories • have removed the locking mechanism at exit doors

Electrical Safety:

- 89% of the factories have eliminated the lint and dust from electrical panels and DBs
- 85% of the factories have lowered the high temperatures at electrical panels and DBs
- 83% of the factories have provided earthing connections for electrical components

Structural Safety:


- 91% of the factories • have mended the cracks at beams and columns

Improving sector governance

Stakeholder engagement

Meeting with Better Factories Cambodia

17 July 2023 - Cambodia

A meeting was organised with International Labour Organisation (ILO) Better Factories Cambodia (BFC) with auditors and trainers among the 21 participants from the organisation. A key discussion point was LABS Tool Box, a resource developed for factories to promote electrical, fire and structural safety and to create awareness on safety, risk mitigation and remediation.

Joint Factory Visit with Better Work Vietnam

26 July 2023 - Vietnam

A joint factory visit, involving teams from LABS and ILO Better Work Vietnam (BWV), was organised to exchange processes and best practices addressing safety concerns and to gain insights into the impact created by the LABS programme in factories. The joint walkthrough in the factory was carried out with factory officials to review remediations, implementation of Safety Management Systems, and fulfilment of graduation criteria by the factory. The BWV team requested LABS to share the documents outlining best practices, which they plan to incorporate into their training materials for factories. LABS will continue to collaborate with BWV to further foster cooperation.

14 August 2023 - Cambodia

Key Outcomes:

- TAFTAC and CFA will include LABS Standards as guidelines on their website if LABS Standards are included in the new National Building Code
- Brands' support will be sought to expedite remediation
- Additional focus will be given to remediating the Severe Priority 1 issues that were identified during LABS Assessments

Meeting with Development on Engagement with DKI Jakarta (Regional-Provincial) Disaster Management Agency

9 August 2023 - Indonesia

The LABS Team in Indonesia met with the DKI Jakarta (Regional-Provincial) Disaster Management Agency to explore collaboration opportunities in formulating indicators for disaster-resistant buildings in DKI Province. The Disaster Management Agency mentioned their interest in adopting LABS standards related to electrical, structural, and fire discipline for implementation in public buildings and facilities. They requested the LABS team to define which parts of the standards can be adopted.

Meeting with Ministry of Land Management, Urban Planning & Construction, Cambodia

15 August 2023 - Cambodia

A meeting was held with H.E. Dr. Chhann Sorphal, Director General of the Department of Construction at the Ministry of Land Management, Urban Planning & Construction, along with other officials from the ministry. The purpose of the meeting was to discuss the LABS Methodology & Standards for Cambodia, the National Building Code for the country, and the potential utilization of LABS Standards as guidelines on the ministry's website.



Brands Ethics Working Group (BEWG) meeting

25 August 2023 - Gurugram, Haryana, India

Attendees: Representatives from 20+ global brands

LABS contributed to the BEWG meeting in Gurugram and presented the Programme along with its benefits and progress thus far to the brand representatives. Key points included aligning LABS Standards to country standards, the cost of remediation and Programme acceptance. The Programme received positive feedback from the brands in attendance.

IDH CFO Visit to LABS Factory

15 September 2023

Lizet Friesen, CFO - IDH, visited a LABS factory in India to experience the LABS assessment process, see the field-level impact, and hear directly from the factory management and workers about their journey with the LABS program.





Apparel Export Promotion Council (AEPC) meeting

19 September 2023 – Gurugram, Haryana, India

LABS engaged in the AEPC meeting in Gurugram and discussed the collaborative efforts to promote safety culture in the industry.

Second Annual Platform for Gender Equality in Cambodia's Apparel & Footwear Industry

25 September 2023 - Phnom Penh, Cambodia



Taking forward the work initiated last year on Gender Equality in Cambodia's Apparel and Footwear sector, LABS Initiative hosted its 2nd Annual Platform meeting in the country, uniting key stakeholders to discuss and address issues related to gender equality within Cambodia's apparel and footwear industry.

The workshop, supported by IDH, was organised in Phnom Penh, Cambodia. Over 40 organisations participated in the event including government representatives from the Ministry of Labour and Vocational Training, the Ministry of Women's Affairs as well as diplomatic missions including the Embassy of Australia in Cambodia and the Embassy of the United States in Cambodia. Non-Governmental Organisations (NGOs) (e.g., GIZ, Oxfam, United Nations Development Programme (UNDP), United Nations Population Fund (UNFPA), Swisscontact, and ILO BFC) joined, as did trade associations, (including, but not limited to the American Chamber of Commerce in Cambodia, European Chamber of Commerce in Cambodia, TAFTAC, CFA and CGTI) Brands (e.g., Carter's, Primark, Marks & Spencer and Amazon) and factory representatives.

During the event, participants engaged in discussions focusing on two main themes: "Breaking the Social Norms for Gender Equality" and "The Importance of Women in Leadership Roles for Safety in the Factory." These discussions delved into critical topics, including addressing pay gaps, expanding leadership opportunities for women within the sector and improving working conditions.
